

THE LOS ANGELES MEMORIAL COLISEUM



Known as "The Greatest Stadium in the World", the Los Angeles Memorial Coliseum is a National Historical Landmark and living memorial to all who served in the U.S. Armed Forces during WWI. The Coliseum has been considered a civic treasure for generations of Angelenos, and is the only venue worldwide to host two Summer Olympics (X Olympiad in 1932, XXII Olympiad in 1984) and will soon host a third (XXXIV Olympiad in 2028.) The building also proudly hosted Super Bowls I and VII, the 1959 World Series, and has been home to USC Trojan Football since 1923. From Mick Jagger to the Harlem Globetrotters, the Grateful Dead to Billy Graham, Evel Knievel to Pele, and John F. Kennedy to Van Halen, the Coliseum is the stage for the unbelievable, the unforgettable, the iconic, and the best in human endeavor and achievement.

This technical guide, a supplement to the LA Coliseum Promoter Guide, provides detail and specifications on many aspects of the venue. Please do not hesitate to contact us with any questions or assistance needs.

VEHICLE ACCESS

Vehicle access to the Coliseum is located on the west side of the venue via Bill Robertson Lane.

For access to the concourse area, use Gate 16 (3900 Bill Robertson Lane, 90037)

For access to the field, use the field tunnel (3960 Bill Robertson Lane, 90037)

Additional vehicle access can be coordinated from S. Coliseum Dr. at the Broadcast Compound and Gate 33.

All vehicles and deliveries entering must either have previous approval for access or must always display appropriate identification. Upon load-in completion, all vehicles must be removed from any public access areas, including golf carts. Load-out may only be started once the facility has been determined to be completely clear of any patrons, typically a minimum of one hour after the conclusion of an event.

SECURITY AND HOURS

The Coliseum has a 24-hour security watch at Gate 16 with delivery access from 6:00am – 4:00pm. Load-in days are calculated on a maximum 14-hour shift. For additional hours, please discuss with your event manager. Additional fees may be required.

Medical will be staffed during load-in for any production with a structural build or for more than 8 hours. Medical is always staffed during events.



COLISEUM LOCATIONS



The Coliseum is comprised of five main areas:

- Field Level: contains the playing field, field turf areas and field court.
- Locker Rooms: elevated slightly above the field level; accessible only from the field tunnel.
- Street Level/Concourse: main level of entry to the Coliseum; access to the Peristyle and Olympic Plaza.
- Upper Concourse (UC) Level: second level of the Coliseum seating bowl
- <u>Scholarship Club Tower (see Rooms):</u> premium seating area of the Coliseum, featuring multi-use areas, conference rooms, and suites.




SCHOLARSHIP CLUB TOWER

Scholarship Club Tower Booking Policy

Members of the Trojan Athletic Fund (TAF) Suite, Loge Box, and Club Seat holders have an exclusive first-right-of-refusal to purchase their Scholarship Club Tower seats for all Coliseum events. TAF members have an exclusive first-rightof-refusal 'opt in' period of 72 hours prior to the beginning of the public on-sale or pre-sales. The Event organizer is responsible for setting the price for all manifested seats in the Scholarship Club Tower. Suites and Loge Boxes cannot be ticketed individually, including the 'President's Suite 201', except for designated 'Party Suites' 501, 502, 521, and 522. The Coliseum retains the right to use suite 212 for all events. The Press Box level may not be publicly ticketed. The 1923 Club rooftop deck is available for standing room only public ticketing up to 499 in capacity.

Heritage Concourse

This front alfresco area offers 19,000 square feet of versatile event space topped with an incredible view, multiple full-service bars and kitchens, and a dozen branding opportunities on our IPTV monitors.

All food and beverage charges will be based on the Guaranteed Guest Count received three (3) business days prior to event. Any changes made with less than 72 hours notice may be subject to additional charges.

Labor Charge of \$200 will be applied for each catering attendant and/or bartender required.



Every team member holds accountability for understanding, observing and ensuring our Responsible Alcohol Service standards are maintained at all times.

Coliseum Responsible Alcohol Policy

- · 2 alcoholic beverage limit (maximum), per person per identification
- Drinks cannot be purchased for other guests without additional guest(s) present and able to provide a valid form of identification
- · Must be 21 years of age and older to purchase alcohol
- · We card anyone that appears under 35 years of age

Please note: Possession of a valid ID is a legal requirement. If a guest cannot provide a **valid ID** if one is requested, they CANNOT be served. An ID that is expired is considered **invalid.**








ELEVATORS

The Coliseum has 8 public elevators, 2 service elevators, and 2 freight elevators. Dedicated service elevators for the Scholarship Club Tower are located at Tunnel 9, and service all floors of the Tower. ADA access to the upper concourse is provided by elevators 3, 9 or 10. Freight elevators are located at Section 15 (west end) of the Coliseum for access from the concourse level to the upper concourse level (max weight 4500 lbs.).

There is no elevator access to the locker room or field level.


There are six main entrance plazas, located at Gates 1, 4, 8, 19, 23 and 28. Additional service and access gates are located in other areas. Gate 7 is our Founders Club Entrance, with access to service the Scholarship Club Tower. Gate 14 is configured for Media entrance. Gate 31 can be used as an entrance for special events on the Peristyle or Olympic Plaza. Gate 16 and 33 are used for vehicle access.

The Coliseum has a total of 119 CEIA PMD2 Plus Elliptic Enhanced Walk-Through Multi-Zone Metal Detectors that can be deployed for state-of-the-art screening technology for weapon detection.

ESCALATORS

Three reversible escalators are located at Tunnels 4, 11 and 19. Each escalator is 48 inches wide, and has a capacity of 10,000 patrons per hour.





FIELD LIGHTING

The Coliseum field lighting was overhauled in 2016 using Musco Lighting's 328 SportsCluster Green™ LED luminaires. The complete solution is engineered – incorporating advanced structural, electrical, and lighting components – to provide a cost-effective, trouble-free lighting system. The system uses 459 kW energy use at full power and reduces energy consumption by 19% compared to the prior lighting, while increasing vertical light levels by 65%.

There are 8 LED field light towers.

- Approximately 30 seconds from on to full brightness
- · Lights turn on and off without a cool down period
- · Lights can be programmed in a variety of lighting patterns

Jeff will be conducting a site survey of the Coliseum as well as actively monitoring equipment, frequencies and transmissions during the event. The result will be a coonfidential database of frequencies in use that can be used to pre-determine potential conflicts and interference. He will also be working on game day to monitor and tag equipment being brought into the Coliseum, track any unregistered frequencies and identify non-compliance.

Licensor has the right to approve all novelty items sold at the event. Please see Prohibited Items for a list of items not allowed in the venue. All temporary novelty stands used during an event must meet City of Los Angeles Building and Safety Department standards. Your event manager will help determine locations based on the event footprint. USC Bookstore is the preferred LA Coliseum merchandise vendor, with co-branding opportunities available.



TICKETING

Walk-up sales for Coliseum events are handled through ticket booths located at Gates 1 and 19. The booths can accommodate up to 21 window locations for ticket sales, will call and/or customer service. The Main Box Office is located at Gate 29 for ticket operations, advance ticket sales, and customer service.

UTILITIES

Utilities are charged based on kWh (kilowatt hours) rate from the Los Angeles Department of Water and Power (LADWP). The Coliseum has a baseline allowance of 3700 kWh. Additional use is charged at a rate of 0.17 per kWh. After 10,000 kWh the rate is 0.52 per kWh.





VIDEO/SCOREBOARDS

Towering above the west end of the Coliseum, our Daktronics video board has a physical dimension of 150' x 40', making it the second largest video display in any college football stadium. It features state of the art clarity (via excellent 15mm resolution), and the ability to broadcast in full HD.



WASTE HAULING

The Coliseum has four (4) 40-yard compactors and sixty (60) 3-yard bins for use. Additional 10-yard and 40-yard roll off services can be provided through Athens Services. Requests must be submitted to the Facility Operations Manager with at least 48 hours of notice.

The Coliseum is committed to Zero Waste. Zero Waste is a set of principles focused on waste prevention that encourages the redesign of resource life cycles so that all products are reused. The goal is for no trash to be sent to landfills, incinerators or the ocean. Additional custodial costs may be incurred for this service. Additional planning/requirements will be necessary to ensure an event is zero waste compliant.



ACCESSIBLE SERVICES



Recent Upgrades

- Every Coliseum gate has a priority line for guests with mobility restrictions until 30 minutes prior to kickoff Within the final 30 minutes before kickoff, all lanes are open to all guests
- Outside of the Coliseum, some curb ramps were enhanced to increase accessibility from key parking lot approaches
- The number of ADA accessible seats has significantly increased
- Accessible seating sections feature in-seat service for patrons in wheelchairs or with restricted mobility.
 Information cards are provided at your seating location during the event
- Handrails and additional aisles have been added to simplify movement about the stadium for guests with mobility restrictions
- Renovations also feature additional semi-ambulatory seats (aisle seats with arm rests that raise to make it easier to transition in and out of the seat

Seating

The Los Angeles Memorial Coliseum can accommodate patrons in wheelchairs or with restricted mobility. The Coliseum features multiple areas on the concourse level that do not require ramps or lifts to access.

The Coliseum has 274 ADA general admission seats and 16 ADA seats on club level. The Scholarship Club Tower, Lou Galen Club and 1923 Club have ADA furniture and seating. ADA farm tables are available on Founders (levels 2 and 3) and Suites (level 5) upon request. Coliseum Clubs have ADA seating available. ADA furniture is available for temporary hospitality areas during events.

For guests that need additional assistance reaching seats in the upper levels of the Coliseum, escalators are located adjacent to Tunnels 4, 11, and 19.

Ticketing

ADA Tickets are sold as ADA and companion. ADA Tickets are sold through the same methods of distribution, in the same types and numbers of ticketing sales outlets, and under the same terms and conditions as other tickets sold (e.g., presales, promotions, lotteries, waitlists, and general sales.)

Disabled guests can purchase three additional tickets for seats next to the wheelchair space, provided that the seats are available at the time of purchase. If fewer than three additional adjacent seats are available for purchase, the guest with disabilities must be offered tickets for seats that are as close as possible to the accessible seats. Adjustments can be made by the box office as tickets are sold.

On event day, guests who previously purchased a non-accessible ticket but require accessible seating will be accommodated on a first-come, first-served basis, based on availability.

Parking

ADA Parking is available in Exposition Park. Marked ADA spaces may not be reserved and are subject to availability based on arrival. Event parking permit holders may park in ADA spaces, provided they have a valid ADA placard to do so.

ADA shuttle service is available around Exposition Park to transport ADA guests from the parking lots to gate entrances.



Drop-Off and Pick-Up

Drop-off and pick-up for guests with accessibility needs is located on Exposition Park Drive after entering from South Figueroa at W. 39th Street. Please be aware drop-off and/or pick-up may be difficult due to heavy traffic and congestion. Due to post-game traffic patterns, pick-up in this area may be delayed up to 45-60 minutes after the game until streets can be re-opened for access.

Closed Captioning

Closed captioning services are provided for all major events. The service provides text of all public address announcements during the game. Guests can access the service from the browser on any smart phone or mobile device.



Food and Beverage

In-seat dining available for ADA guests. An information card will be provided at each ADA seat location with available menu items and instructions to text "ADA SERVICE" to 213-263-4007 Ushers and customer service staff will also be trained to request service as needed. Concessions personnel or wait staff are assigned to each ADA seating area for assistance.

Non-fixed condiment counters, tables and pop-up set ups are at proper ADA height of 28" to 34" and have a minimum width of 36" for the full depth. A clear floor space in front is provided of 30" x 48" running parallel to the counter.





Gate Entrances

Every gate has a priority line for guests with mobility impairments up until 30 minutes before kickoff.

Gate 14 Media Check-In Counter is at proper ADA height of 28" to 34" and has a minimum width of 36" for the full depth. A clear floor space in front is provided of 30" x 48" running parallel to the counter.

Gate 29 Security Booth Counter is at proper ADA height of 28" to 34" and has a minimum width of 36" for the full depth. A clear floor space in front is provided of 30" x 48" running parallel to the counter.

Hearing and Visually Impaired

Assistive listening devices for fans with hearing or visual impairments are available for checkout at the Customer Service station, located in the Coliseum West Administration Building across from Tunnel 11.

Service Animals

A service animal is any dog that is individually trained to do work or perform tasks for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual, or other mental disability. Other species of animals, whether wild or domestic, trained or untrained, are not considered service animals.

Service animals are welcome inside the Los Angeles Memorial Coliseum. Service animals must remain on a leash or in a harness at all times unless either the handler is unable because of a disability to use a harness, leash, or other tether, or the use of a harness, leash, or other tether would interfere with the service animal's safe, effective performance of work or tasks, in which case the service animal must be otherwise under the handler's control (e.g., voice control, signals, or other effective means).

An aisle seat can be reserved for guests with a service animal, if available.

An animal relief area is provided at Gate 33 in the Olympic Plaza.

Wheelchair Transport

The Los Angeles Memorial Coliseum provides assistance inside all areas of the stadium to guests with special needs. This service is free of charge and can be requested through Customer Service by calling (213) 747-7111 or email *lacoliseum@usc.edu*. During event hours, call or text (213) 263-4007. The Coliseum does not rent wheelchairs or crutches.

FIELD GUIDELINES



The Coliseum field is maintained as a competition-ready world class athletic playing surface. Field availability is subject to conditions and at direction of the Sports Turf Director.

Footwear

Cleat usage is only permitted during events involving athletic competition.

For filming productions, all rehearsals need non-cleated footwear. Key actors/actresses can wear cleats with the prior approval from the Sports Turf Director, and if approved, will be limited to wearing cleats only during live filming. Approved shoes are Trainers, Business Flats, and Turf Shoes. Sport cleats, women's flats and heeled shoes require prior approval.

Weather

Field availability is subject to weather conditions. In the case of rain, all field activities will cease, and all equipment will be moved off the field onto field turf or cement areas. In the event of lighting, all field activities must cease for a minimum of 30 minutes until lighting within a 6-mile radius is cleared.

Parking and Tunnel Area

A 20ft Fire lane must ALWAYS be maintained in the tunnel due to the fire regulation. The Coliseum may designate a staff member to jury traffic in the tunnel depending on size and scope of production. Parking is restricted in the tunnel and limited to safety vehicles only. A 10ft clearance is required in front of storage areas.

Vehicles/Motorized Equipment

Motorized vehicles and equipment intended for the field must be submitted to the grounds department with pictures and full specifications (including weight, dimensions, tired, etc.) no later than 24 hours prior to event day. The Coliseum offers motorized carts (with Coliseum operator) and hand carts with field approved tires and proper turf protection to use during load in/load out.





Field Protection

Any equipment or material landing on the field must have a protective surface underneath it. The Coliseum will provide or source turf protection for equipment and material


Pedestrian Flooring is required if:

- The event involves prolonged period of stagnant pedestrian action (EX: concerts, speaking engagements, corporate parties, etc.)
- Events involving heavy pedestrian movement may require pedestrian flooring if over 2000 people.


Drivable Flooring is required if:

- · Anything over 1500 lbs
- The Coliseum has 16,000 sqft of drivable protective flooring. All drivable flooring must be a minimum 12 ft wide Speed of traffic should not exceed 10 mph

During football season, flooring can only be laid down on the field outside the playing surface.









EVENT PARKING

There are 13,615 parking spaces within 3800 feet of the Coliseum within Exposition Park and the USC Campus. Spaces can be reserved in advance and re-sold as pre-paid parking options to support your event

TRUCK STAGING/BUS PARKING

Exposition Park has surface lots with truck and bus parking available. Other off-site lots can be secured to accommodate production trucks and crew.

DIGITAL PARKING

USC and the Coliseum partner with Park Mobile to provide a digital parking solution. Park Mobile lets your guests easily find and pay for parking using their free application or online and delivers a touchless experience.

DIRECTIONS

The Coliseum is located at 3911 S. Figueroa St. Los Angeles, CA 90037 just off I-110 and I-10 in Exposition Park. We are one block south of the University of Southern California, and near several attractions and dining options.

During events, the Coliseum partners with Google Maps and the Waze Global Event Partners Program to provide road closures and specific parking lot location to improve the travel experience for guests.

The traffic pattern for major events at the Coliseum relies on a <u>right-turn only</u> policy. Left-turn lane pockets around Exposition Park will be closed.

METRO

The Coliseum is easily accessible via the Metro E Line (Expo) at the Expo Park/USC or Expo/Vermont Stations. https://www.metro.net/riding/guide/E-line/

The Metro E Line can be easily accessed with connections at 7th Street/Metro Center in downtown Los Angeles to the B(Red) and D(Purple) Lines, and at Pico Station to the A(Blue) Line. Fans using the L(Gold) Line can make an easy transfer at Union Station for a connection to the E Line. Enhanced service will also be provided during game days.

Guests are reminded to purchase a \$3.50 round-trip fare at the beginning of trips to avoid lines when the games are over. Each person, including children over the age of 5, must have a valid TAP card and remember to tap before each boarding.

Last trains leave from Expo Park at 1:30am for transfers (2:10am for Expo Line only – no transfers). Enhanced service every 6 minutes begins two to three hours prior to kickoff and continues one to two hours after the game.

When leaving the Coliseum, exit the North side of the Coliseum at Gates 19 or 23.



BUILDING SAFETY REQUIREMENTS



BASIC SAFETY

- · All aisles and tunnels must remain clear and be maintained as stipulated in the floor plans approved by LADBS/LAFD.
- · Smoking is prohibited in the building
- All props and pageantry elements must have up-to-date Certificates of Flame Retardancy. Copies of Certificates must be made available to Coliseum management prior to load-in.

LOS ANGELES DEPARTMENT OF BUILDING SAFETY (LADBS)


Temporary Special Events (TSE) being held within the City of Los Angeles are required to be inspected and approved by LADBS inspectors prior to holding the event. The following qualify as a TSE provided they have a maximum duration of 5 consecutive days:

- Tents or canopies, larger than 450 square feet, on a residential property.
- Tents or canopies, larger than 12 feet in length or width, on a commercial property.
- Stages or platforms more than 30 inches above grade (structures higher than 30 inches intended for live loads require approved engineering prior to inspection).
- · Grandstands or bleachers.
- Structures higher than 12 feet.

CABLE INSTALLATION

All cables need to be labeled (at both ends) with the network name and designated location's nomenclature. For example: ESPN HI LT EZ -1; FOX Low Rt EZ - 2. Any stranded or unidentified cable may be removed. All temporary cable installation must be properly secured and not be allowed to droop through pedestrian or viewing areas. Cable-troughs and "J-hooks" are provided in most areas. Cables must be secured and covered in pedestrian areas or seating areas.





ELECTRICAL/WIRING

Vendors and exhibitors must adhere to LADBS requirements to pass inspection:

- · All outside power sources must have the proper permits to be used.
- · All extension cords used during an event must carry a ground.
- All splices and connections must be done in a workman like manner and with UL listed productions for the
 correct application. No items can be wired together with wire nuts and tape, unless they are placed in proper
 electrical boxes.
- All cables must be properly insulated, with all single wire positioned in conduit, free of abrasions, bubbles
 or cuts.
- · No bare single wiring can be exposed at any time.
- · All lighting must employ the correct corresponding wire size.
- · These cables are the minimum required to pass inspection:
 - 400 amp: 4/0 cable, minimum ground cable requirement #2
 - · 200 amp: 2/0 cable, minimum ground cable requirement #4
 - 100 amp: #6 cable, minimum ground cable requirement #8
- · An overcurrent device (i.e. distro box with main breaker) must be provided within 25 feet of house panels.

FAN CONDUCT POLICY

In order to ensure a safe and enjoyable environment, we ask that fans refrain from the following behavior at all events.

- · Profanity or other offensive language or gestures, whether spoken, written or appearing on apparel
- · Smoking (including vaporizers, e-cigarettes and smokeless tobacco)
- Intoxication or excessive alcohol consumption or signs of substance impairment that results in irresponsible behavior
- Bringing or attempting to bring prohibited items into the venue
- · Throwing of items or liquids
- · Entering the playing field or court at any time
- · Fighting or other threatening behavior, including verbal or physical harassment
- · Failure to retain ticket and/or present it to event staff if requested to do so
- · Resale of tickets at the venue
- · Violation of state or local laws
- Failing to follow instruction of stadium personnel or stadium policies

FAILURE TO COMPLY MAY RESULT IN EJECTION OR ARREST

Fans are encouraged to report inappropriate behavior to management personnel. For assistance, call or text 213-263-4007. Message and data rates may apply.



PROHIBITED ITEMS

All persons and their belongings are subject to metal detector screening and bag inspection prior to entering the Coliseum. Guests are encouraged to arrive early to avoid delays. All prohibited items will not be allowed inside the Coliseum.

The following items are NOT ALLOWED in the Coliseum:

- Bags, Backpacks or Purses which do not meet Bag Policy guidelines. Hard or Soft Coolers, Baskets, Packages
 or Containers;
- Alcoholic Beverages, Bottles or Cans. (Factory sealed bottles of water, 17 oz. or less, are allowed; limit 2 per person);
- · Illegal Drugs and Weapons including Firearms, Knives, Explosives, Fireworks, Lighters and Laser Pointers;
- Professional Cameras (lenses longer than 3") and Camera Equipment, Selfie-Sticks, Tripods and Video or Audio Recording Equipment;
- Banners, Sticks, Poles, Inflatables, Frisbees, Balls, and Unsliced Fruits or Vegetables;
- Umbrellas, Balloons, Strollers, Skateboards and Folding or Beach Chairs;
- Pets (Service Animals are allowed);
- The Coliseum is a smoke-free environment. Smoking and smoking implements are prohibited in any area of the Coliseum.

Please do not conceal items. Have all items clearly visible inside an approved bag. All Bags must meet Bag Policy guidelines and are subject to inspection upon entry. For more information on the Coliseum Bag Policy, please visit http://www.lacoliseum.com/beclear.





CLEAR BAG POLICY

The Coliseum prohibits bags, backpacks and other containers from entering the venue, with the following exceptions:

- One bag that is clear plastic, vinyl or PVC and does not exceed 12" x 6" x 12", or a one-gallon clear plastic storage bag (Ziploc bag or similar);
- In addition to one of the clear bags noted above, guests may also carry in a small clutch bag or purse approximately the size of a hand, with or without a handle or strap; and
- An exception may be made for medically necessary items after proper inspection.

Prohibited bags include, but are not limited to: purses larger than a clutch bag, coolers, briefcases, backpacks, fanny packs, cinch bags, luggage of any kind, oversized seat cushions with pockets or metal structures, computer bags, camera bags or any bag larger than the permissible size.

These measures are designed to promote public safety while encouraging guests to limit the items they bring into the venue to create a more efficient screening and entry process. We ask that all items are visible when entering the venue. The fewer items that are concealed, the quicker the process becomes.

All approved bags are subject to inspection upon entry. For more information on the Coliseum Bag Policy, please visit www.lacoliseum.com/beclear.

The clear bag policy affects the type and size of the bags permitted into the stadium — not the items (keys, makeup, combs, phones, wallets, and credit cards) that you would normally bring to a game. Guests can still carry these items in their pockets. Guests will also be allowed to openly carry a blanket or jackets into the stadium, though they will be subject to search.





FLOOR PLANS

An approved floor plan or seating plan for the Coliseum must be submitted before any event can occur or tickets are placed on sale. The plans must be approved by the Los Angeles Fire Department. Any modifications to these plans can only take place with the approval of the Los Angeles Fire Department.

ON-SITE FIRE INSPECTOR

Certain events may require the presence of an on-site Fire Inspector. Responsibility for this cost will be with the licensee.

PERMITS

As the permits required for an event can vary considerably, please consult your Event Manager to discuss permits that may be required for your event. Permits are typically required for:

- · Los Angeles Department of Building Safety (LADBS) temporary structures
- · Los Angeles Department of Public Health (LADPH) outside food activations, sampling
- · Los Angeles Fire Department (LAFD) occupancy for public assembly, vehicle displays, pyrotechnics
- · Los Angeles Police Department (LAPD) traffic planning, risk management





Unmanned Aircraft Systems (UAS) - "Drones"

The Coliseum does not permit the use of drones during an event. At all other times, a permit is required by LAFD and operates under authority of 14 CFD - Part 107 which requires:

- Be compliant with FAA Part 107 https://www.faa.gov/uas/commercial_operators/
- Provide a copy of the Remote Pilot Certificate
- Provide your FAA drone registration or remote ID https://www.faa.gov/uas/getting_started/register_drone/
- Provide a plan of operation including description of flight activities, flight times, location of controller/pilot and take-off and landing areas.
- · Provide certificate of insurance of general liability coverage naming University of Southern California as additionally insured.
- Pilots must keep the UAS within line of sight at all times. UAS must be flown at speeds below 50 knots and below 400 feet above ground level. UAS are also required, generally, to maintain a distance of 500 feet from all production personnel.

Pyrotechnics

All use of pyrotechnics, compressed gases and other special effects in conjunction with an event must have the expressed written approval of the Los Angeles Fire Department and Coliseum Management.

- Every display shall be under the control and supervision of a Pyrotechnic Operator licensed by the State Fire Marshal and shall be conducted under conditions as required by LAFD.
- · Every applicant for a permit to conduct a fireworks display shall submit evidence of having a Fireworks Public Display License or a Fireworks General Public Display License granted by the State Fire Marshal.
- The fireworks in public displays shall be located, discharged and of such character so as not to be hazardous to persons or property.

The Coliseum works closely with Pyro Spectaculars on many productions, including USC Football and the annual July 4th celebration.





PERMANENT BUILDING SIGNS

All permanent building signage must remain up and not be covered. Additional temporary event signage may be added where space allows. There is no non-compete or exclusive categories currently (subject to change without notice).

TEMPORARY EVENT SIGNS

The Coliseum partners with AAA Flag & Banner to produce stunning graphics transforming simple concrete walls and metal fence lines into opportunities to showcase your brand and enhance your event experience.

Your Event Manager can provide a robust installation deck referencing easily identifiable codes to reference for quick quotes and faster ordering of common signage areas.

Please note AAA Flag & Banner is a preferred vendor with years of experience working with this National Historic Landmark. Your production is not required to contract with AAA, but there may be limitations to installation at the venue with outside contractors. All scope for installation with an outside contractor must be reviewed and approved by Coliseum Management in advance of the event. Temporary event signage must be fully removed within 72 hours after the event or as conditions may require. Your production is responsible for any damages that may be caused from adhesives or other structural mounting. Please let us know if you have any questions before proceeding.

FLAG POLES

The east rim of the Coliseum features 74 flag poles (43 on the northwest end and 31 to the southwest). The exterior of the Peristyle has 12 total poles with an even split of 6 on the north and 6 to the south of the Olympic cauldron.

BANC OF CALIFORNIA STADIUM

During LAFC games (only), exposure of partnership signage is prohibited from Coliseum areas visible from Banc of California stadium. This affects mainly the area from Olympic Plaza to Gate 1. This is only applicable during the same time an LAFC event is taking place.

NOISE CURFEW

While there is no formally defined curfew within Exposition Park for noise, we generally suggest to not extend your event past 11:00 PM. Exposition Park is boundaried by the campus of USC and residential neighborhoods.

Sound should be no greater than 110 dB at FOH position.
